#### PARK SITES DONATED TO PARK DISTRICT

#### THE WOODRIDGE FIRST PARTY PLATFORM

PLANK II - CONTINUED DEVELOPMENT OF YOUTH ACTIVITIES AND PROGRAMS.

The Woodridge First Party, long interested in the welfare of the children in the Village, feels that the subject is deserving of a prominent position in our 1971 platform.

As a Village Administration, we plan to continue to utilize as intensively as possible all of the available open space and other community properties in cooperation with the Park Districts and School Districts in the area.

An excellent example of the highest and best use of the land - the most intensive and best planned use of the land - is the 83rd Street site.

On this site, approximately 11 acres in size, School District 68 will construct several much-needed class-rooms at one end, the Park District will utilize the center of the property for recreational facilities (about 7 acres), and on the western edge, the Village has constructed a Public Works Department Building which will be the temporary home of the Village Administration and Police Department until a Village Hall can be constructed in the Woodridge Center Development.

Another good example is the Park District's leasing for \$1.00 the 40 acre high school site in the vicinity of 71st & Janes, from School District 99.

The Woodridge First Party Administration will also continue its support of the Adult Advisory Committee, and to the programs and activities recommended by our new Youth Coordinator, Mr. Doug Fonder, whose office is at the Village Hall, and the Youth Council, created by Ordinance 70-5, passed April 2, 1970.

The Woodridge First Administration also plans to institute a study to determine the feasibility of a permanent structure for use by the Youth of the Village.

We must evaluate and compare the desireability of a facility for the Youth only with a general purpose structure. Again, this evaluation will require the assistance and knowledge and cooperation of the Park District, School Districts, and Youth Groups.

#### CAMPAIGN PHILOSOPHY

Last week the opposition party distributed a newsletter which in content was-in most polite termsscurrilous! The publication of halftruths, unfounded and misleading inferences and innuendos is an insult to the intelligence of the voters and their interest in the betterment of the Community. The Woodridge First Party and its candidates will not reduce themselves to the obviously low level of its opposition by responding in kind. Instead, the campaign of the Woodridge First Party and its candidates is to present positive, progressive and substantive programs to the voters, together with the vow by the candidates to fulfill those programs to the best of their ability.
