ROBERTS NEW VILLAGE PRESIDENT!

PAY FOR OFFICIALS VOTED DOWN

In the Finance Committee report Trustee Gene O'Connell presented for approval of the board the accounts payable in the General Fund for the month of March.

Voucher 611, in the amount of \$360, was to have been for salaries for village officials. After O'Connell gave the breakdown on the distribution of the \$360, Trustee Wally Larson said that "as long as we have outstanding legal fees of \$2500 and need for emergency equipment, we shouldn't pay salaries at this time." Trustee William Roberts answered that the intent of the Finance Committee was that a token payment be made as some kind of a "thank you" particularly for those officials who would not be in the new administration. President Werch explained that payment can not be made after an official is out of office.

County Residents to Get Unique Tax Bill

DuPage County Deputy Treasurer John J. Kelly estimated that DuPage residents will receive their tax bills beginning next week. All bills, real and personal, will have an itemized statement showing the amount each taxing body receives from the bill. It is reportedly the first time in the United States that the residents of a county have received a tax bill presented in this manner. One small township in DuPage County received itemized tax statements last year.

The new IBM 1401 machine installed in the treasurer's office makes this new procedure possible and is drawing wide attention from officials in neighboring cities, counties and states.

Donald R. Smith, county treasurer, believes this system to be one of the greatest steps forward in the education of the property owners as to how their tax payments are determined and distributed.

Editors Note: Under normal procedure, tax bills are sent by the county to the mortgage company, paid by them from escrow payments made by the homeowner during the year and forwarded to the homeowners marked paid.

Stray Dog Bites Small Child

Monday morning of last week a dog wandered into the area where Cathy Kruger and her playmates were playing. While two of Cathy's friends were at the side of the animal, Cathy stood at its head. Apparently a sore tail was touched and the dog retaliated. Cathy was bitten on both arms.

Oliver Kruger reported the incident to Police Chief Elmer Messer. With only the dog's description to go on, the police force located the animal by Wednesday morning.

According to Chief of Police Messer, the dog's owner, Mr. A. Lee, produced a 1961 rabies certificate, and Cathy did not have to undergo the series of shots.

CAUCUS FAVORITES WIN IN SCHOOL ELECTION

Hill, Wiggins To Serve 3 Years On District 68 Board

The voters of school district 68 elected Ned Hill and Marvin Wiggins to three year terms in the balloting April 8. Woodridge School (precinct 2) was by far the most active polling place with 294 voting here as compared to 59 at Goodrich School (precinct 1).

REPUBLICANS TAKE TOWNSHIP OFFICES

Republican candidates swept the field in the Lisle Township election April 4, while Democrats made an impressive showing in each position. Out of the 962 registered voters in district 2, which includes Woodridge, only 382 voted. About one-third of these were Woodridge voters. In district 2 straight Republican ballots totaled 143 compared with 119 Democratic.

In our district, Pat Riedy(R) who was elected township supervisor, beat his opponent, Vincent J. Venard(D) 208 to 162. The total township vote gave Reidy 2,142 to Venard's 1,401. Balmer E. Saylor(R) won the race for assessor over George Cleland(D) taking the district by only 18 votes, the township by 2,172 to 1,392. Michael Linz(R) was elected town clerk over Edward Fraser(D) in district 2, 186 to 169, in the township, 2,017 to 1,485.

John J. Case (190)(2,085), Julius T. Hankinson (209)(2,065) and Joseph T. Bast (183)(2,053), Republicans, won as auditors over Democrats Patricia Davis (170)(1,447), Charles J. Gauger (145)(1,285) and Joseph J. Griffiths(175)(1,312).

Lester P. Reiff(R) and Bruce R. Fawell(R) won the justice of the peace race in the second justice district. Fawell received 4,080 votes and Reiff received 3,748 over Justice Party candidates Richard Kenney, 1,954 and Anton Stupay, 1,699. Independents, Leonard Bales and Donald Ford, received 964 and 644 votes respectively.

In the race for constable, Donald E. Springborn(4,332) and Doyle Steck(3,822) both Republicans were voted in over Justice Party opponents Edward Kelley (1,737) and Richard Hamlin(1,712). Also in the constable race were independents Fred Boltz(662) and Elmer Terry(602).

The second justice district includes Lisle, Naperville and Winfield townships.

TOWNSHIP BOARD PASSES 5 CENT GRAVEL TAX

A levy of 5¢ per \$100 assessed valuation for gravel for Lisle Township roads was authorized by the township board by resolution April 4 at the annual meeting. The tax was levied for one year only although the original petition requested a four year levy. Money from this tax is to be used for gravel only and not for maintenance expenditures which are paid from the road and bridge taxes.

McPherson, McGrath, Werch, O'Neill Win

The unofficial results of the village of Woodridge April 18 election are:

In relatively light voting at the polls Tuesday, the village residents elected as their president for the next 4 years, William T. Roberts. Roberts won 163 votes as compared to his opponent, Edmund Gilbert who received 152.

The 3 trustee positions for 4 year terms will be filled by Virgil McPherson (227), Joseph McGrath (203) and Leon Werch (169). Losing in this race were Steve Kvackay and Maurice Hennessey who received 152 and 104 votes respectively.

In the race for village clerk Mary Ann O'Neill received 173 votes to win over Virginia Radtke who received 143.

The police magistrate's office was uncontested and Douglas Weikel will continue to serve the village in this capacity.

TOURNAMENT

The Woodridge Home Owners' Assn. ping pong singles tournament was brought to a close on April 10 and 11.

In the mens tournament, four out of seven games were needed to win the match. In the semi-finals, Jeffrey beat Trondsen four out of four games and Narducci took Martin four out of five. In the finals, Jeffrey beat Narducci four out of six games to retain his championship title. Martin won the consolation match by taking Trondsen five out of six games.

Three out of five games were required to win a match in the women's playoffs. Jayne took Trondsen three out of three games in the semi-finals and O'Connell beat Lee three out of three to match Jayne and O'Connell in the finals. Jayne triumphed in three straight games to become this year's new women's champion. No consolation game was played.

Trophies will be awarded to first and second place winners at the April 26 WFOA meeting at 8 p.m. at Woodridge School.

VFW Presents Flag To Village

At the April 6 village board meeting Steve Nikonchuk, on behalf of the V.F.W. Woodridge Memorial Post, presented an American flag to the village of Woodridge. Village President Werch accepted the flag, expressed appreciation and recommended that the Woodridge Post form a color guard. Nikonchuk, vice commander of the Post, expressed his approval of the idea and said he would refer the suggestion to the officers of the Post for further action.

Certification of Census Received By Village

The village of Woodridge received an elaborate certificate from the Secretary of State to certify the population figure of 542 as of April 3, 1961 based on the 1960 Federal census.

Hill won by a substantial margin at both polling places, being named on 270 of the 353 votes cast. Wiggins received 161 votes beating Steve Radasevich, 7728 Westview Lane, by a slim margin of only 20 votes. Wiggins won on the strength of the votes cast at Woodridge School, whereas Radasevich won the Goodrich vote 34 to 17. Art Krause, 3002 76th Street and James Mersimer of 7725 Butternut Court trailed on the ballot receiving 46 & 44 votes respectively.

Ned Hill lives at 2926 Everglade and is the father of 7. He is a former high school and grammar school teacher and prior to his election was chairman of the school board's Citizen's Advisory Council.

Marvin Wiggins of 2017 Crabtree has four children and has taken an active part in other school systems in providing challenging facilities for the talented child.

Both men took their place on the seven member board at the April 10 meeting.

The balloting for the three school board members for Downers Grove Community High School, district 99, resulted in the election of the three unopposed candidates.

At the Woodridge School polling place, 92 of the total 1,678 ballots were cast.

Lyle F. Yerges received 1524 votes (81)*, C. E. Hacklander, incumbent president, 1527(79)* and Mauritz E. Gahlon, 1529 (78)* *Woodridge votes.

New School Board Meets

At a special meeting April 10, the School Board of District 68 canvassed the results of the election held April 8 in which Ned Hill and Marvin Wiggins were elected members of the Board. Of the 294 votes cast 12 were spoiled. These votes came from the Woodridge polling place.

Don C. Miller was re-elected president of the Board and Maureen Mc Millan was elected secretary. Consideration is being given to the hiring of a clerk-accountant to record the minutes of Board meetings and to handle the accounts.

Contracts have been awarded to Talmadge Construction Company for the construction of the one room addition to Goodrich School. POLICE COURT HAS BUSY MONTH

Douglas Weikel, police magistrate, heard 24 cases in March. Fines and costs totaled \$276. Of this amount \$27 was suspended. There were 15 traffic violations, 5 vehicle license cases and 4 dog tag cases.

Dear Editor:

The "Water Rate" was a subject touched upon in the April 6, 1961, issue of the WOODRIDGE NEWS REVIEW and, no doubt, this is an item of great interest to every homeowner in the area including my wife and me.

On April 13, 1961, I was given information regarding the establishment of water rates, at the Chicago office of the Illinois Commerce Commission. The rates are not "set" by the state when a utility corporation initially applies to the Commission for a certificate to operate. The proposed rates are computed by the Utility Corporation and fully enumerated in their application. The proposed billing period (monthly, quarterly, etc.) for charges to a customer is also stated.

A hearing is held by the Commission and the Utility is required to justify the proposed rates. An application which has been correctly submitted in proper form, with accurate calculations, is usually accepted if justified to the Commission's satisfaction and a certificate to operate granted.

Each year, a complete financial statement must be filed with the Commission. The statement is reviewed and if a fair rate of return on the Corporation's investment is realized, the established rate would continue. When the rate of return exceeds or falls short of a fair return, the Commission will direct that the rate be adjusted.

The gentleman who related this information to me repeatedly stated that the files and financial reports may be examined by any individual at 160 North LaSalle Street, Chicago. The Commission

offices are located on the 19th floor. It was also stressed that all hearings held by the Commission are open to the public.

Trustee Larson reiterated that, though he would like the money and felt that all deserved it, he thought that the legal fee outstanding is large and that there were other areas where the funds could be used. O'Connell tried to determine if the need for emergency equipment/the other area Larson was referring to had just recently become apparent. (editor's note) O'Connell is referring to the 79 year old woman who was injured in unit 2 in the village during windstorm March 27.

It was decided to discuss the need for emergency equipment as new business later in the meeting.

The motion to pay salaries was not passed as there was a tie vote: Larson, Benckendorf and McPherson voted against the motion and O'Connell, Roberts and Werch voted for it.

An attempt was made by O'Connell later in the meeting to encumber this amount(\$360) for legal fees in reference to Larson's pointing out the large outstanding legal fees. This motion was voted down 4 to 1. The only affirmative vote was O'Connell's.

As to emergency equipment and any use of the \$360 for that particular purpose, it was decided that the Public Protection Committee make a study of the problem.

VILLAGE BOOKS TO BE AUDITED

Though an official audit of the village books is not required for another 2 years, a motion by Trustee Gene O'Connell to accept C.P.A. George Riekard's bid of \$140 to audit the books, was passed.

Trustee Lewis Benckendorf seconded the motion saying that he thought it was a good idea because of the change of administration.

1962 Budget Approved

A \$23,620 budget was unanimously approved by the village board at the April meeting. This was \$1,000 more than recommended by the Finance Committee headed by Trustee O'Connell. President Werch asked for the additional amount in the Streets and Alleys Fund which brings the total to be applied for this purpose to \$9,000. The balance of \$14,620 comprises the General Fund budget. \$8,720 has been earmarked for general administrative purposes and \$5,900 for public protection.

General Fund revenues, not including Streets and Alleys funds, were estimated to be \$11,120 from sources other than property taxes. A \$3,500 tax levy will make up the balance.

Werch asked the present Finance Committee to present an appropriation ordinance for passage at the May board meeting based on this budget.

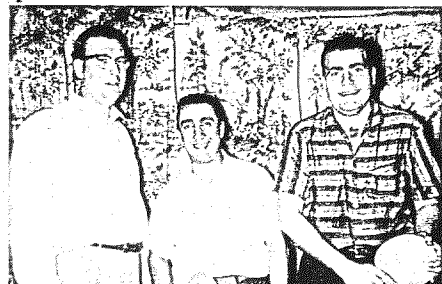
