MAJOR POLICE CHANGES INDICATED

Messer Resignation Revealed

Chief of Police Elmer Messer tendered his resignation to retiring President Leon Werch on Saturday, April 15, Werch stated. Messer requested that the resignation become effective as of the May 4 village board meeting. He stated that if asked by the village board, he would remain on the force, but only in the capacity of Chief of Police. However, he did say he would function as an advisor "as long as they want me" to whomever is appointed Chief, since he feels that his past experience might be helpful to the police department. He further stated that Roberts will be the "chief Chief of Police as Werch was."

Messer first served the village as a trustee, being elected to that post in the special election-held in Sept. 1959. He acted as chairman of the Public Protection Committee while on the board. He resigned from the board on Jan. 12, 1960 to be - come head of the village special police force.

RESIGN ON ELECTION NIGHT

In less than an hour after the returns were in in the village general election, four Woodridge policemen handed in their resignations to Chief Messer. The four are Charles A. Hague, John Russo, LeRoy Radtke and Jerome Szczepaniak. Each requested that his resignation be made effective April 30.

HAGUE'S SECOND RESIGNATION

Hague, one of the original members of the police force, had resigned previously and was off the force for some time. He rejoined the force at his own request in Oct. and has served as a juvenile officer in addition to his other duties since then.

Radtke was promoted to Acting Sgt. on Dec. 1. He drew a five day suspension from Messer in early April. He then returned to duty as a patrolman.

When contacted by WNR both Hague and Radtke had no comment.

Szczepaniak, who established the Police Boys Club, stated that the club had been dissolved as of April 19. He gave out side business interests as his reason for leaving the force.

Russo, who joined the force last summer, and Szczepaniak will continue to perform their duties as patrolmen until their resignations are acted upon. This action is expected to take place at tonight's village board meeting. Both Hague and Radtke have turned in their badges to Messer and will not perform any further

TWO REMAIN ON FORCE

John R. Loomis and Edward Arndt, both of whom joined the force last summer, are the only two remaining members of the special police force. Loomis has been patrolling at the school in the mornings, and Arndt has been performing regular patrol duties.

When contacted, President Roberts said, "that the village can be assured of adequate police protection."

Virgil McPherson, chairman of the Public Protection Committee, when asked if he had any future plans concerning the police department, stated that he had not been consulted regarding the resignations and could therefore not consider future plans.

Messer stated that he has 5 applications on file. One of the applicants has not yet been

interviewed.

The oaths of office were administered by Douglas Weikel, police magistrate. Wm. Roberts was sworn in as village president and Mary O'Neill as clerk. Virgil McPherson, Joseph McGrath and Leon Werch were sworn in as trustees. Douglas Weikel will take his oath as police magistrate of the county cost.

DEBRIS CAUSES SEWER SCHOOL ENROLLMENT **OVERFLOW**

The sanitary sewer in the ravine between Crabtree and Jonquil Lane North overflowed on Tuesday, April 18. The Woodridge Sewer and Water Co. was contacted. The DuPage County Board of Health was informed the next day by a resident of the area. The repair was begun April 19. Wayne Bryant, spokesman for the W. S. & W. Co. explained that the delay was due to their having to obtain heavy equipment in order to perform the work. He stated that it was necessary to remove foot-wide boulders and rebuild the sewer. The Company believes juveniles are responsible for the damage. Be cause of the weight of the sewer cover and the size of the boulders, it would have to have been older boys, Bryant said. He pointed out that this is the type of thing that increases operational costs which are in turn reflected in the rates charged the consumer.

JUMPS FROM 101 TO 337

To help residents of School District 68 to assess the tremendous tasks accomplished by its school board, a special report was published. Enrollment figures showed an increase from 101 pupils in June of 1959 to 234 in June of 1960 and to 337 in March 1961. As a result, the teaching staff increased from 4 teachers in June 1959 to a principal and 19 teachers in June of 1960. By March 1961 the school system was staffed by a principal-superintendent, assistant principal-teacher, 13 full time teachers and 2 part time teaching specialists (a speech correctionist and a physical education teacher).

To handle the many problems which arose during the building of the new Woodridge School and to accomodate the influx of children, the seven man school board held 19 regular meetings, 14 special meetings and 4 executive meetings as well as uncounted committee meetings.

At present the estimated replacement cost of land, buildings and equipment is \$550,000. This represents 18 classrooms which can support 540 students at 30

The \$50 for Woodridge School was designated to be spent for equipment for the uncompleted kitchen.

HERE'S HOW VILLAGE **JUDICIARY OPERATES**

The judiciary branch of the village of Woodridge is vested in the police magistrate's office. Established along with the village government in Au gust of 1959, the court had no legal work until January 1960 when the first traffic violations were heard. Since that time, there has been a gradual buildup, as population increases, until now the court rules on an average of fifteen minor traffic violations per month. One civil case has been heard and several felonies have been on the court calendar. No Woodridge resident however, has been involved in any of the serious cases.

The court is located in the village hall. The courtroom seats twelve persons; citation holders plus spectators. As there are usually empty seats, the court invites and welcomes any citizens that care to attend and observe proceedings. Court sessions are held every Thursday night at 7:30 p.m.

Sitting behind the bench is Police Magistrate Douglas Weikel. Weikel entered the job with no experience, but after attending court sessions in Downers Grove, and studying the State Statutes, he has learned some points of the law and the demands of his office.

In his words, "It has been quite an education in learning to temper justice. It is a very real responsibility, holding someone's reputation in your hands."

The mailing in of traffic tickets is not allowed, except under special circumstances, because the Magistrate likes to meet personally with the offender and hear the statement offer-

Changed Address On Your Driver's License Yet?

If you are one of the residents of Woodridge who has not changed the address on your drivers license, you should do so as soon as possible. The law states that notice should be given within 10 days after moving.

A sample letter, sent to C. F. Carpentier, Secretary of State, Springfield, Illinois, can be worded thus: "In accordance with statute 952: 6-122, notice is hereby given of the change of address of (name) from (old) address to (new) address.

Drivers license number is ___.

A new license costs \$1 plus 24¢ notary fee.

For a 4¢ stamp, however, you can send a short letter to the Secretary of State, stating your change of address, and be legal until your present license expires.

YOUR TAX BILL-

EXPLANATION OF AN EXPLANATION

Regarding the editor's note on page 1 of the last issue regarding taxes, real and personal:

REAL ESTATE TAXES

Real estate tax bills are normally paid by the mortgage company from escrow payments made by the homeowner during the year and forwarded to the homeowner marked paid.

If your loan is with National Homes Acceptance Corp., you should have received a card for your signature authorizing the county to forward your tax bill to NHAC. NHAC, however, has informed its mortgage holders that even though this card was signed and sent to the county collector's office, the procedure will not take effect until next year. For this reason, Woodridge tax bills were sent to the Elmhurst National Bank, or to the individual homeowner, whichever mailing address was held by the county collectors office.

Those real estate tax bills that were sent by the county to the Elmhurst National Bank, rather than to the mortgage company, will either be sent directly to the homeowner or the mortgage company and processed in the manner explained above.

Donald R. Smith, county collect or, states that individuals who wish direct mailing of their real estate tax bills must register their name and mailing address with them at the county courthouse. Smith further stated that the tax lists do not necessarily show home ownership, but merely designate the recipient of the tax bill.

In any event, if you received your real estate tax bill, it should be forwarded to your mortgage company for payment by them from your escrow account.

PERSONAL PROPERTY TAXES

Personal property tax bills are sent directly from Donald R. Smith, county collector at the courthouse in Wheaton to all county residents. The individual then pays his personal property tax bill himself by sending his payment along with the IBM card back to the county collector.



The Record Hop was pretty good, The Millionaires were there, plus a few dance contests and you could get Jim Lounsbury's autograph free.




He stated further that the danger is greatest during the evening rush hour peak.
