# ELECTION DATE POSTPONED

# **MAGISTRATE ELECTION** RESET TO FEB. 3rd

Following the conclusion of the regular January village board meeting, a special meeting was held to postpone the police magistrate election until Saturday, Feb. 3, 1962.

This special meeting was called by the unanimous petition of the board of trustees.

President William Roberts explained to the board that the legal notice of the election missed the deadline for publication in the pre-designated newspaper, the Suburban Life.

It is required by state statutes that publication of a legal notice of an election be not less than 15 or more than 30 days preceeding the election.

The deadline for filing petitions for the office of police magistrate has also been changed to midnight Jan. 20.

Anyone who has lived in the state for one year, in the county for 90 days and at his present address for 30 days is eligible to petition for the position.

## O'CONNELL QUESTIONS VILLAGE BOARD

Gene O'Connell, 2936 Westridge, asked the village board for information on snow plowing at the January village board meeting.


O'Connell asked why the village is plowing in the unincorporated area and on whose authority an "agreement" was reached between the Woodridge public works commissioner and the township road commissioner.

O'Connell referred to the Dec. 28 issue of the WNR in which Patrick O'Neill, superintendent of public works, explained that salt and cinders are being provided to the village by the township road commissioner and that part of the agreement is that the village plow, salt, and cinder the roads in the unincorporated area.

O'Connell also wanted to know who would pay for any property damage incurred by the plow or truck in the unincorporated area and why the village taxpayers should pay for operating costs of plowing this area.

# Twin Santas Ride Through Woodridge

Twin Santas distributed approximately 725 Christmas stockings to Woodridge children Sat., Dec 23. Their 2-hour tour of the village with police car and fire truck escorts was made possible through the financial help of 10 Woodridge organizations. They co-sponsored the event under the supervision of the Woodridge Homeowners Association.

Contributing organizations were the Police Benevolent Association; the Woodridge fire department; Woodridge Athletic Association, V.F.W. Post 4739; the Womens Auxiliary of the V.F.W.; Mothers Club; Garden Club; Surety Development Corporation, Woodridge Sewer and Water Company; and the Woodridge News Review.

About 275 stockings remained when the rides were completed. All but 60 of these were donated to the pediatrics wards of Hinsdale Hospital, LaGrange Community Memorial Hospital, and West Suburban Hospital in Oak Park.

Dan Hollowell of the W. H. O. A. said that any Woodridge child who did not receive a stocking may have one of the 60 that are left over.

# **Mechanical Failures Hamper Snow Removal**

Between Dec. 9 and 29 the snow removal crew worked a total of 75 hours keeping Woodridge streets passable, said Patrick O'Neill, superintendent of public works, in a statement to the WNR. He said he personally spent 60 hours on the

After the heavy snowfall on Friday, the 22nd, the crew worked from 11:15 p.m. until 5:00 a.m. when the plow blade hung up on a curb and cracked a tie bolt between the plow and the underframe of the truck.

The crew was able to partially repair the damage and resumed plowing until the hydraulic system went out. O'Neill blamed this on the early morning breakdown. PLOW - Turn to page 3, col. 4

## Road Commissioner Interviewed

Responding to an unusual number of complaints concerning snow removal from Woodridge area streets, the WNR interviewed Jean Burton, Lisle township road commissioner.

Burton was queried about the arrangement between the township and the village. See details on page 1 column 1. He said that he was doing the village a "favor". He explained this remark by saying that he was still holding the road bonds for units 1 and 2, and until such time as they are released, the burden of care and maintenance remain with the developer. Burton went on to say that he would not release the bonds before next spring.

He offered no explanation for not plowing the roads this year, even though he has done so for the past two winters, except to re-affirm that "it is not my responsibility."

When the road bonds are released, the village will assume the responsibility for the roads in the incorporated area and the township will assume responsibility for those in the unincorporated area.

# O'Neill Resigns As Public Works Supt.

Superintendent of Public Works Patrick O'Neill submitted a letter of resignation to the board of trustees at the Jan. 4 village board meeting.

The trustees accepted his resigna-

tion to be effective Feb. 1. A letter of commendation is to be

sent to O'Neill.

O'Neill was appointed Superintendent of Public Works Dec. 1, 1960, and organized the public works department.

His letter explained that he wanted to be free to devote his entire efforts to his new position with a new corporation. He also expressed willingness to assist his successor in dealings with the state department of highways.

The letter of resignation concluded with, "My year of service to the village has been most enlightening to me. I have had the satisfaction of organizing a department and hope that my successor will continue to build on the foundation laid by myself and the men on the Public Works Department."

#### COMMUNITY CENTER STUDIED

A newly formed special studies committee is to study and prepare a program for a community center. The plan is to include building costs, land costs and land availability. It is to be ready by the March board meeting.

# TO THE EDITOR

To The Editor of the Woodridge News Review:

The Crabtree barn, in terms of property devaluation and utter frustrations, is an obvious tragedy to the barn area residents. There are, however, deeper tragedies. To understand these, one must be familiar with the history of the barn and of the village government.

The barn was not to exist beyond the spring of 1961, according to a letter written by the developer. Covenants and commitments filed with the County and the V.A. projected three homes on the lots in question.

The Village government was formed by the first few residents of the Woodridge area. The village boundary lines zigged and zagged to such an extent, that it took hundreds of words to legally describe. Many who had no voice in the preceedings, found themselves outside the Village limits and unable to vote when elections were finally arranged at a later date.

The feeling over this was intense and bitter. Ugly charges were raised. Of all the non-Village group, the barn area group alone, decided that as a civic gesture of cooperation, we would ignore the charges, forget the bitterness, and voluntarily annex to the Village.

Our former Village president was delighted at this turn of events; pledged interest in our problems, including the early removal of the barn. "We are your neighbors and certainly have your interest at heart more so than a large and indifferent county" was a favorite statement by many of those directly concerned with the new Village.

Much to our dismay, we were soon "rewarded" for our cooperation. The annexation brought the barn lots inside the Village limits, and outside of County jurisdiction. The Village, via an agreement with the developer, moved in the fire truck and Police car some time after the annexation.

Even then we were not "irate". After all, we still had all the various promises as to the barn removal soon. Our desire was still to be cooperative. Two barn area residents even joined the fire department!!

All major candidates, in the April '6l elections, vowed to do "something about the barn situation" if elected. Our area "irateness", with all of its fury, came only after it became more than clear that no one really intended to do something except to give promises to remove the barn in the far dim and foggy future.

When the only non-Village group, at their own initiative, ask for annexation; and then is so ill-treated by the Village; such treatment can only result in a crushing loss of trust and respect. While the rules of fair play are violated so completely, there simply is no chance of building the type of Village that we Woodridge Village people can be proud of and that we want. The Village's existing approach to problems deprives us the very opportunity to solve our problems in honest and fair ways. Describing all of those who would dare raise their voice in protest as "detractors", and further condemning the ill-fated barn committee for those very actions which circumstances forced on that committee, only adds to the problems.

All this, then, is the deeper tragedy of the Crabtree barn.

Because of the time element there will be no Church School that Sunday.





Beginning Jan. 15, the Woodridge Mothers Club will collect used clothing for needy children and adults in the U.S. and overseas. This drive will end Jan.



Question: What do you like most and what do you like least about living in Woodridge?

Mr. and Mrs. Ronald Ruble

When asked what they like most and what they like least about Woodridge, Mr. and Mrs. Ronald Ruble of 7630 Sprucewood answered that they dislike the inconvenience of being so far from the shopping district. "In the sales promotion and build-up of the homes here, a shopping center was something that was to have been built in the very near future. We have been here almost a year, and still nothing has been done," said Mr. Ruble.

Both are elementary school teachers, and as such, one of the reasons they bought their home here was the existence of a school. They were happy to see the people of the community taking enough interest in the school to vote in favor of the last two referendums. They hope there will be a kindergarten here by the time their young son is of school age, because they consider it very essential. "But it seems unlikely", lamented Mr. Ruble, "as there are and probably will still be shortages of other classrooms."

Mr. Ruble likes the rolling hills that lend an air of country living and also the small town atmosphere whereby the local people participate in running the government.

"Too many resignations by elected officials indicate they are not giving enough of themselves to their offices," believes Mrs. Ruble. Her husband countered that the community should give elected officials more backing. He further believes that no matter what or where the community, the same groups of people are active in politics because they have the time, the drive, and the interest.

Although some board meetings are not well attended, Mrs. Ruble feels that on the whole participation in community affairs is good.

They are very happy and satisfied.






