## RESIGNATIONS HIT POLICE DEPT.

### 3 Policemen And 2 Clerks Resign

In presenting the resignations of Mr. and Mrs. Ed Arndt from the Woodridge police department, Trustee Walter Larson, chairman of the public protection committee, read their letters. The letters explained that because of the illness of Mrs. Arndt, they would no longer be able to serve. Arndts' letters expressed their enjoyment in working with fellow police and officials.

Alfred E. Jensen also resigned. In his letter of resignation, Jensen explained he has two jobs and only has time to give on Sundays.

Another change in the department is that Charles Hague who has been the acting lieutenant will now serve as a grade 1 police officer. Larson read Hague's letter which said that Hague requested the change and had no desire to express any reason for this action.

In his letter of resignation from the Woodridge police department, John Russo said that he had been an officer in the village of Woodridge for 18 months and in that time had enjoyed working with his fellow officers. He said he felt he couldn't do the job any longer due to village officials who were untrained in the field of police work telling him how to do his job. Turn to page five, column two

### Ordinance Sets Procedure For Magistrate Election

The only item on the agenda for the Jan. 19 recessed Woodridge village board meeting was the adoption of ordinance 62-1. This ordinance sets the election date and outlines the election for police magistrate.

The election is now set for April 7, 1962.

This new election date allows for the 50 day interval between the final date for filing petitions of candidacy and the election. This 50 day interval is one of the new provisions in the 1961 revised state statutes.

Sat., Feb. 10, is the final day for filing petitions of candidacy for this election for police magistrate for the village of Woodridge.

It is necessary to have lived in the state one year, in the county 90 days and at your present address for 30 days to be eligible for candidacy.

Petitions are to be obtained and filed with the village clerk, Mrs. Eleanor Murphy, 7620 Catalpa.

The ordinance names Barbara Cooling, 7706 Butternut, judge of election.

The polling place for Woodridge voters in the Feb. 17 high school referendum will be at Woodridge School. The polls will be open from 9 a. m. to 7 p. m.

## Vote On 63rd St. High School Site Set For Feb. 17

"DOWNERS GROVE HIGH SCHOOL DISTRICT 99 VOTERS CAN APPROVE THE PURCHASE OF A SITE FOR FUTURE EXPANSION, YET THIS LAND ACQUISITION WILL NOT INCREASE TAXES."

School Supt. Glenn E. Pickrel underscored this statement Jan. 15 at the Board of Education meeting, in presenting a bond retirement schedule for the proposed \$125,000 issue. An election on the purchase of 48 acres at the southwest corner of 63rd and Dunham has been called for Saturday, Feb. 17.

Pickrel pointed out that yearly increases in assessed valuation show that this small issue would bring no increase in the high school bond rate. But a delay in buying land for future use might well cost the taxpayers considerably more, particularly if acquired on a lot-basis rather than acreage.

Members approved the superintendent's recommendation and adopted a retirement schedule calling for payment of the bonds over a five-year period. This means that by 1967 the issue would be paid off.

The proposed site is ideally located for future expansion of high school facilities, school officials agreed. In the southern portion of the 32 square mile Turn to page two, column one

## Plans Made For Community Betterment Committee

Members of the Woodridge Home Owners' Association made recommendations for the formation of a community betterment committee at the meeting held in the village hall, Tuesday, Jan. 30.

The proposed committee, to be comprised of 2 or 3 representatives from

each organization functioning in Woodridge, would attempt to solve problems considered to be of prime importance to the community. It was stressed that all projects undertaken would be accomplished through the efforts of all village residents, and are not intended as additional responsibility for representatives already actively committed to parent organizations.

W.H.O.A. President George White stated that the main purpose of the committee would be to prevent overlapping of projects and to provide better communication between organizations.

The Mothers Club, V.F.W., post 4739, the village board, Woodridge Athletic Association, and the Woodridge News Review were represented at the meeting. They heard suggestions for projects made by the presiding W.H.O.A. board members and those in attendance. These included solution of the village barn problem; encouraging voters to the polls; street lighting for the intersection of 75th street and Woodridge drive; cleaning up of park areas; and a possible toboggan and sled slide in the creek area.

Representatives were asked to have the recommendations discussed at their organization's next meeting, and if participation in the committee is approved, to have representatives appointed to serve on the committee. The organizations were also requested to decide on the project, which, within their own structure, is considered most important. C.B.C. members will then confer at a meeting tentatively scheduled for 8 p.m. Monday, March 5 in the village hall. At that time a governing board will be set up and an initial project selected by the committee.

### Snowbound Roads Trigger County Board Action

Many calls from residents of new subdivisions whose roads have not as yet been accepted by township road commissioners have prompted the DuPage County Board of Supervisors Road Committee to seek means of obtaining relief for snowbound residents. Without acceptance, these roads are not the responsibility of either the township or county road authorities.

Paul J. Ronske, Chairman of the DuPage county board of supervisors, called a meeting of the road committee on Mon., Jan. 22, 1962, to discuss action to solve this problem. At this meeting, the States Attorney, James Fitzgerald, was requested to prepare an ordinance requiring a developer to maintain roads for a two year period or until roads were accepted. This ordinance would make road maintenance a condition of the developers performance bond.

Attorney, Mark Bemis, assistant supervisor of Milton Township, who attended this meeting said that subdividers in the county are required to furnish performance bonds before road-beds are Turn to page two, column two

## Residents Protest Ditch Hazards

Village drainage ditches were discussed at the February village board meeting.

Most of the residents of Crabtree, west of Woodridge, signed a petition to have a discussion of the matter on the agenda for this meeting.

Village President William Roberts asked if a spokesman for the group was in the audience. Alfred Zettler, 2615 Crabtree, stepped forward and said that there was no official spokesman for the group but that he had typed the petition.

Zettler pointed out the hazards and problems that exist in these drainage areas, that is, children from all over the village playing in drain pipes, embankments peeling away and debris collecting in the area. He suggested either covering over these ditches or fencing them in. He explained that the signers of the petition were looking to the village for information as to how to proceed.

President Roberts said that some months back an investigation was started. The ownership of the area has to be decided before any action can be taken. He said further that a meeting was planned for Feb. 3 with the builder's attorney.

John Sinyard, 2715 Crabtree, commenting on the actual ownership of the property said, "I must own one part of the property. One of my property lines is on one side of the ravine and the other property line is on the other."

President Roberts said that he hopes to have the answer at the next board meeting. He explained that they have been working on it since last summer.

district which extends to Route 66, the area is one of rapid residential expansion with many new home developments and considerable space for additional subdivisions. The tract is adjacent to village boundaries and the sanitary district, a factor in considering extension of facilities.

Pickrel pointed out that when school districts maintain adequate facilities for their children, property values are kept at proper levels. Where areas fail to meet school needs, property values decrease.

"A district which keeps abreast of school needs and meet these needs builds a better community," Pickrel commented. He pointed out that the high school expansion is part of such a picture here.

Discussing plans for the 1962 school year, the superintendent reported the need of five more classrooms to accommodate higher enrollments. The following year, seven more rooms will be needed. He told members that a study was being made of the possibility of renting outside space or using portables rather than resorting to a shift system.

Pickrel voiced his objection to double shifts. Educationally, this brings a drop in the quality of an instructional program, he said. Also community problems could follow when large groups of teen-agers are free for an entire morning or afternoon. But if the community refuses a site and the Board interprets this to mean that additional space will not be provided, the superintendent said he felt the only alternative would be to go to a shift system.

The possibility of expanding the present high school plant was questioned as an alternative solution. Members agreed that if classrooms were needed only for 500 or 600 students, this might be considered. But with projections showing continual growth in high school enrollments and with considerable space available for new housing developments, the board felt no further expansion of the present plant could be considered.

The official resolution calling for the referendum on Feb. 17 submitted in draft form by Attorney Clifford M. Carney, is slated for adoption at an adjourned session Monday night.

## ROAD "ACCEPTANCE" DEFINED

In answer to questions about street maintenance raised at the January board meeting by former trustee, Gene O'Connell, a letter from William Roberts, president of Woodridge, to O'Connell was read at the February meeting. The letter explained that at the time a village board approves a subdivision plot, there is an "acceptance" of the right-of-way (which constitutes a roadway).

This "acceptance" is a term used to designate that the right-of-way becomes public property and the responsibility rests with the village for maintenance.

The letter stated further that apart and separate from the above-mentioned "acceptance" is an additional "acceptance" of improved streets and roads. This acceptance refers to the official village action in approving fulfillment of specifications submitted by a developer and for which they submit a surety bond. In this sense "acceptance" refers to the manner, method and material used in approving the roadway, not to the right-of-way, and has no bearing on the physical maintenance, such as snow removal.

laid. The road-bed must set for a period of one year before surfacing of the road. Subdividers are given two years to complete their work. He said that he feels that during that time they should be responsible for all road maintenance, including snow removal, repairs etc.

Bemis also said it was suggested that the Highway Commission may require test borings to be made by a private engineering concern, cost of such tests to be born by either the subdivider or road builder. The reason for test borings is to determine the compacted depth of bituminous surfacing. County law specifies that county roads must have a compacted depth of bituminous surfacing not less than 2 inches.

The road committee will meet Tues., February 6, with township road commissioners to take further action. This meeting will be held in Wheaton in the County Highway Committee Room at 10:00 a. m.

When contacted Feb. 2, Chairman Ronske re-stated that "all the forces of the county board of supervisors would be used to force contractors to upgrade the roads for which they are responsible, if it is deemed that delinquencies exist at their doorsteps."

He added that he has been "assured of co-operation from both township road commissioners and from the office of the states attorney".

In answer to a question about test borings to determine compacted thickness of roads, he said he thought that road commissioners made test borings before they accepted the roads.

Units 1 and 2 were built under county jurisdiction. At that time the county required performance bonds in the amount of \$220,000 for the roads in these two units.

Lisle township road commissioner, Jean Burton, who is holding the bonds for the roads in units 1 and 2 of Woodridge, said that he will probably have some test borings made before he releases the bonds.

It is up to his discretion to release the bonds when he is satisfied that the specifications have been met. Burton has commented that he does not expect to release them before spring.

The streets in unit 3 were platted with the incorporated village of Woodridge, and bond is held by the village.

In answer to O'Connell's query about liability for property damage by village equipment working in unincorporated areas of Woodridge, it was explained that the village has all-inclusive property damage liability protecting equipment and property.

O'Connell had also questioned the agreement Woodridge had with the township road commissioner, that is, the township would provide salt and cinders to the village and the village would also plow and cinder the roads in the unincorporated area.

It was explained that the agreement was on a temporary basis. To continue, it would be necessary for the village, township supervisors and the state to pass resolutions.

Maintenance of the streets in the unincorporated area has reverted back to the township while the arrangement is being discussed and evaluated by the village and township officials.

Dear Editor:

This year voters all over the country will be asked to select 37 U. S. Senators and the entire U.S. House of Representatives. Adult citizens need only register as a voter to participate in the selection of those who are to fill these offices.

In addition to the national elections, numerous township, county, and state offices will be voted upon. All of us must do our part to assure that Woodridge is well represented at the polls.

There will be a polling place in Woodridge for both the April 10th primary, and the November general election. Excluding Village elections, this will be the first polling place to be established in Woodridge.

However, only registered voters may vote. At present there are only 529 registered voters in the area of Woodridge and environs, which make up the 18th Precinct of Lisle Township. There is a potential of approximately 1,000, making this one of the largest Precincts in the county. This low ratio is, in part, due to the large number of new people moving in.

Anyone who has not previously registered or who has not re-registered since moving may do so at the office of the Village Clerk, Mrs. Eleanor Murphy, or with the County Clerk, at the Court House in Wheaton. Mrs. Murphy has offered to hold a general registration day for our precinct in order to make registration more convenient. Please watch for an announcement of details of time and place. The last day for registration for the April 10 primary is March 12, 1962. Anyone not registered by this date cannot vote. This, of course, applies regardless of political affiliation.

If anyone is in doubt as to whether or not they are registered; I will gladly check the list of registered voters for them.

In closing I ask you to vote. For most of us, little though we are, this is our only voice for better government.

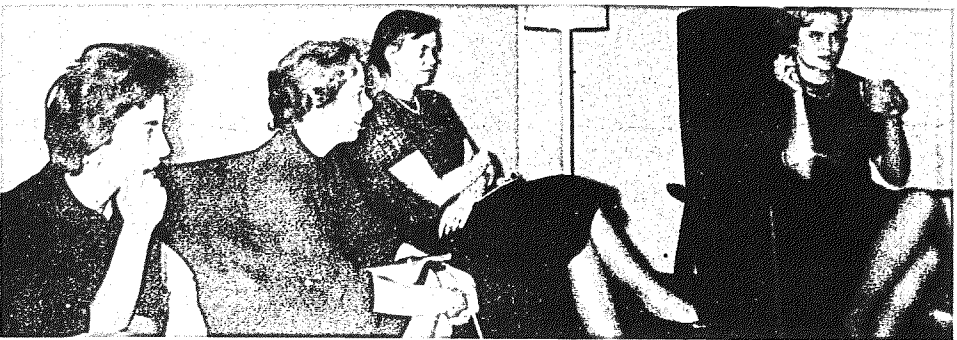
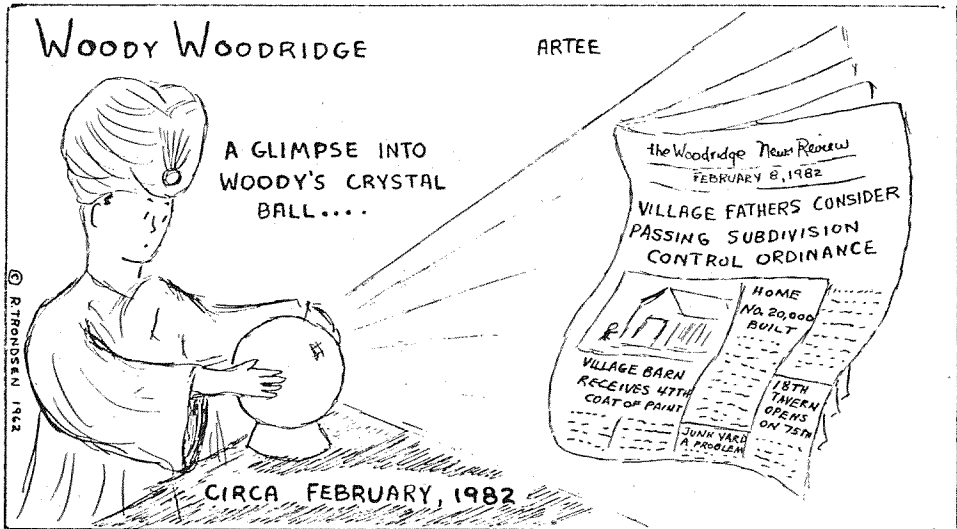

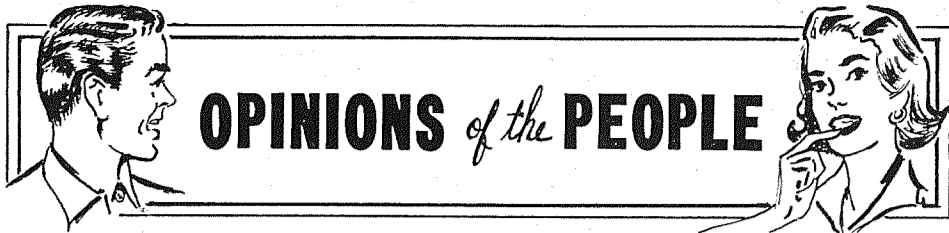

**Mr. & Mrs. Phillip Zuccaro**

Mr. & Mrs. Phillip Zuccaro say they particularly like living in their home at 3031 Jonquil Lane No. because there are so many trees to provide shade and enhance the scenery.

On the other hand, living in the far corner of the community has presented two disadvantages. There is only one entrance and exit to the village down Westview Lane, and in bad weather access is difficult. Along this same line, lack of direct route makes it necessary for their two school-age children (they also have a pre-schooler) to travel a round-about way to school. Mr. Zuccaro expects both conditions to be alleviated when unit 4 is completed because plans call for continuance of Everglade Ave.

The fact that there is so much room for the youngsters to play without the worry of traffic is important to them. Their children also have their own organizations to which they belong - such as scouts and the 4-H Club. Their father believes they probably would not have joined if they still lived in Chicago.

Said Mr. Zuccaro, "The Woodridge Athletic Association has done wonders for the children of this community by acquiring and improving the field and providing athletic equipment and a supervised recreational program." This is especially true, he added, because the W. A. A. has been in existence such a short time and is a non-profit organization.

Heading the list of the problems they have encountered in the two years they have lived here is the lack of a shopping center. To purchase clothes or other items they must travel either to Hillside, Aurora or Joliet.

The opening of Oak Brook shopping center will shorten the distance to about 11 miles said Mr. Zuccaro.

Another problem is the fact that there is no Catholic Church here and St. Joan of Arc in Lisle is overcrowded with no apparent plans to correct the situation. "Extremely high" water bills complete their dislikes.

Mrs. Zuccaro, who stayed close to home in the city, because "there was no one to go with to the doings" enjoys getting together with neighbors for parties and picnics. She is a member of the Mothers Club and also plays in the ping pong tournament, which has enabled her "to meet many more nice people."

The Zuccaros say they find living in Woodridge a new and enjoyable experience.

**Mr. & Mrs. Richard Lowry**

Among the features the Richard Lowrys of 7616 Woodridge Dr. like about Woodridge are the school, the countryside, the type of village government, and the fact that the community is small enough for the people to be in touch with the government.

One of the main things Mr. Lowry likes is the fire and police protection available to residents. A member of the fire department, he believes a better job is done because both departments operate on a volunteer basis. "You have a bunch of guys who really want to do the job and do it well", he explained.

Mrs. Lowry exclaimed that their neighbors are "just wonderful". In the year and a half they have lived here she said they have met more people and

made closer friendships than they ever did in LaGrange where they lived before. There was never the opportunity to participate in activities there because "everyone was set and if you didn't know someone you didn't get in". Here she is treasurer of the firemen's auxiliary and is active in developing a library for the children of Woodridge. Not only does Mrs. Lowry feel she is making a contribution but believes "this gives you experience meeting different people and learning to get along with them."

Mr. Lowry cites the absence of the shopping center that, he said, was promised a year and a half ago as one of the "rather disappointing things." When Mrs. Lowry shops she "makes a day of it" driving her husband to work, shopping in LaGrange, and visiting with her parents who live there. She said she will "definitely shop here" when the center is completed.

About the high water bills which they dislike, Mr. Lowry reports they were told the water rates would decline as more people moved into the village. He commented that more people have

moved in, but the rates have not changed.

He strongly feels that if at least one member of each family were active in some organization this would be a much better community.

Albert J. Zettler, Jr., 2615 Crabtree, speaking from the audience, one of the largest in recent months, expressed his concern about the resignations and asked what was causing the dissension. He asked if it was a clash of personalities that was causing all the difficulty.

Trustee Larson explained that the rules and regulations had been established and that the police department had to follow them. He explained that the village board has sole responsibility for the police department. This responsibility cannot be given to individuals. He added that three amendments to the rules and regulations have been discussed at previous committee meetings and that a representative of the police department sits in at these discussions.

John Russo was in the audience during this discussion between Zettler and Larson. At this point he stood up and asked if he could see a copy of these regulations. Russo and Larson then discussed various points of difference during which time President Roberts reminded Russo that he was a police officer till 12 a. m. The discussion between Larson and Russo continued. When Russo commented that there were several instances of a particular nature... Larson said, "We'll go upstairs and go into that privately. The records are locked up upstairs." The discussion concluded shortly thereafter with Russo commenting that, "I can't do the job and follow the rules so that's why you've got my resignation."

Mrs. Russo resigned her position as police clerk. An executive meeting of the board is planned for Feb. 8.

The Woodridge Policemen's Benevolent Association has been dissolved. After the bills were paid, the balance in the treasury was donated to two Woodridge organizations. The V. F. W. received \$20, and the Cub Scouts received \$13.
