BOARD NEWS

The regular meeting of the Woodridge Village Board, held Nov. 5, 1964, was exceptionally well attended. The audience included Al Kaufmann, president of Surety Builders; Bill Kamphouse of Winston Hills; Ervin Koudelka, president of Winston Hills Homeowners Assn; Robert Dreveny, president of the Zoning Board of Appeals; Thomas Church, chairman of the Plan Commission; Pastor John Swanson of the Prince of Peace Lutheran Church; Rev. John Siple of the Woodridge Methodist Church; Rev. John Kloepfer of St. Scholastica Church, 3 newspaper reporters and several interested citizens.

No comments were made by either Mr. Kaufmann or Mr. Kamphouse throughout the evening which boasted a game of musical chairs with the 5 chairs available to the 20 to 25 people present.

The surprise of the evening came when Mr. Dreveny, president of the Zoning Board of Appeals, speaking in the absence of Mrs. Barbara Cooling, secretary to the Zoning Board, presented a signed and sealed copy of the Zoning Ordinance which Mrs. Cooling unknowingly had in her possession. Mrs. Cooling decided to check her copy of the ordinance after reading an article appearing in the Chicago Tribune stating that it could not be found. (Mrs. Cooling commented, "I had never been asked to check it. Who would have thought that I had been issued the official copy?")

Although Mrs. Cooling's re-appointment at the end of her term to the Zoning Board of Appeals was denied by the Board of Trustees, technically she is

still a member until someone has been appointed to replace her. Consequently she had not turned in all Zoning Board materials in her possession.

This official copy of the Zoning Ordinance, signed by Mayor Roberts and Mrs. Ellie Murphy, former village clerk, was the object of an intense search by the Board of Trustees and Mayor Roberts and was the cause of many harsh words and incriminations from all sides. The Board of Trustees made no comment on the discovery.

The Official Zoning Ordinance was turned over to the Village Clerk for which Mr. Dreveny received a signed receipt.

The official Zoning Map, however, is still "lost".

The local clergymen were in

Launch Winston Hills Social Club

The inaugural meeting of the Winston Hills Social Club was held last Wednesday, Oct. 28, following six weeks of intensive organizational work. The new members were greeted at the door with name tags, eliminating the necessity of individually introducing the 30 women in attendance.

The business meeting began with introduction of officers and a brief outline of the purpose of the club. By-Laws were read and passed, with modifications such as extending the tenure of office from six months to a full year for each officer elected.

Reaction to the plans and programs outlined was enthusiastic, as anticipated. All women present expressed keen

attendance to present views and opinions on a proposed Human Relations Ordinance and attached Resolution. The ordinance is for the purpose of setting up a Human Relations Commission which will work to promote tolerance and good will between racial, religious and ethnic groups within the village; to guarantee fair, and equal treatment and to protect the rights of all the people. The ensuing discussion brought objections to the wording of the ordinance and the purpose or intent as defined in several sections. The clergymen will meet with the trustees and the mayor at a later date to discuss revisions.

Three motions were made regarding litigation against the village; (1) To remove former village attorney James McClure as defense for the Village of Woodridge in the suit Elmhurst National Bank vs. village of Woodridge; to pay McClure for work already done on the case, direct him to turn over all materials and documents pertaining to the case to the present village attorney, Robert Cox and to direct Mr. Cox to proceed with the defense of the village in the aforementioned suit. (Motion carried.)

(2) To direct Attorney Cox to file Substitute Appearance in the suit Corcoran vs. Winston Hills, et al. (Motion carried.)

(3) To hire attorney Edgar J. Elliott (by letter of request from Mr. Cox) to assist Cox in the suit Winston Hills vs. Village of Woodridge.

The third motion was followed by a discussion regarding the advisability of hiring

Mr. Elliott to assist the village attorney. The Mayor and the Trustees plan to meet with the attorneys Monday evening at 7:30 to discuss the matter in more detail.

Trustee Hanson suggested the possibility of a traffic hazard at Rt. 53 and Everglade where Surety Builders is erecting new model homes. He recommended that Surety Builders install street lights to minimize this hazard.

A motion was made by Trustee Hanson directing the Village engineer to prepare a platted map of all village park lands. Mayor Roberts suggested the need for a new, complete village map which would include the park lands. A committee was appointed for further investigation.

Thomas Church, chairman of the Plan Commission, invited the Board of Trustees to meet with the Plan Commission next Thursday evening to discuss a new "barn" site.

Church also recommended to the Board that Winston Park discontinue the erection of street signs stating that they

were not adequate nor acceptable according to village ordinance. He was directed to submit a list of specifications to Winston Hills.

The floor was opened to public discussion at the end of the evening, with only one person using the privilege. Ervin Koudelka, president of Winston Hills Homeowners Assn., asked for clarification of the village ordinance prohibiting the planting of trees in parkways. It was explained that the planting of trees would damage the underground utilities along the parkways.

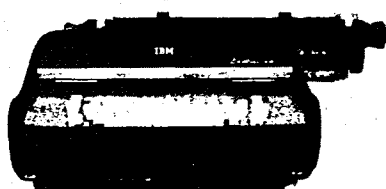

SCIENCE CLUB

SCIENCE FACT #4

REPROCESSING STEEL

One of the triumphs of the last 90 years is that man has learned to make steel, an alloy of iron, abundantly and economically. But what about used steel, what is done with it? Sure, everybody knows that it is hauled away to junk yards. But what then?

Because of earlier methods of producing steel, scrap steel was worthless. But now new ways have been developed to reprocess used steel.

The operation of reprocessing steel is started in the plant junkyard, where collected scrap steel is separated into classes according to size, condition and rust. Also they must be separated to set apart non-ferrous (metals with no iron in the alloy) from those containing iron. The latter is done either by a grinding spark test or by a qualitative chemical test. This separation is essential to avoid harming the furnaces. The steel is then melted, refined, molded and used as other steel. Actually it is better than new steel, for it has been refined twice.
