7. Village Clerk will establish convenient daily hours at the Village Hall.


8. Improved communications between the Board and Village Residents.

Trustee Robert Renaud, who was named chairman protem of the village meeting Thursday evening, occasionally prompted by Village Clerk Faye Hoffman, chaired the board through their official acceptance of Robert's resignation until the swearing in ceremony of Ed Redmond.

Ed has been serving the village as Trustee since April 1963 when the Citizens Action Party (C.A.P.) swept into office.

VILLAGE PRESIDENT, ED REDMOND, ISSUES POLICY STATEMENT

Immediately after assuming the office of president of the Board of Trustees at Woodridge the new village president issued the following policy statement:

"I assume this office without false illusions as to the difficulties that will face this administration. The village has been mismanaged from this office. The Woodridge real estate tax rate is more than 150% higher now than it was in 1960. I am confident that the people recognize that it shall not be easy to patch up a broken egg in four short months.

I assume this office fully aware that many of its officers have not hesitated on occasion to act unmanly; and consequently, shaming the name of Woodridge and its fine residents. We repudiate this ugly conduct as totally unrepresentative of the people of Woodridge who have dedicated many hours of effort to their churches, good government, and their civic and social organizations. We shall accept our victories with humility and should there be defeats, with grace,

I assume this office also fully aware that it has been used as an instrument in an attempt to establish and consolidate a political machine in Woodridge. I repudiate political bossism.

We shall welcome the advice and counsel of all citizens, and we shall encourage them to contribute their talents to the village government. To maintain economy in the government and to maintain taxes at a reasonable level, we will need the services of all public spirited citizens. We are fully aware that they will come for-

### Public Hearing Jan. 16

A tentative public hearing has been set up for Saturday, January 16th at 1:00 p.m. at the Woodridge School Auditorium.

The purpose of this hearing will be to determine whether the citizens of Woodridge are desirious of paying the John Rot Disposal Service an additional \$1.50 per quarter to pick up papers rather than to burn them themselves.

At the present time papers are not supposed to be put in your garbage cans. Village ordinance states that papers be burned in a wire container. Several times a year the Boy Scouts pick up papers left at the curb on pre - designated days.

If the general concensus of opinion at the public hearing is to pay the additional monies; and if the board of trustees agrees with this concensus as being the wish of the majority of the people; and if it agrees this is better than burning, all residents will pay the additional money.

The purpose of a public hearing is to determine the wish of the people. To make your wishes known on this matter that will affect all residents of Woodridge, attend Saturday, January 16th at the Woodridge School.

## BOARD NEWS

Trustee Walter Hansen, speaking as chairman of the building and zoning committee, officially stated that no further new residential construction permits will be issued in Woodridge. 1,000 building permits have been issued by the village and until the state of Illinois has an assurance that the Woodridge sewage treatment plant is sufficient to service more than that number of homes, building permits will be held up.

The Board concurred with Trustee Hanson. In actuality, an examination by the Woodridge News of correspondence between the State Sanitary Water Board and the Woodridge Sewer and Water Company shows that the State had originally set the figure of "1000" in relation to occupancy permits. Having issued 1000 building permits does not necessarily mean that 1000 occupancy permits have also been issued. Nor does the state necessarily mean that the sewerage treatment plant can not handle more than this.

In a letter written to the Woodridge Sewer and Water Company, dated Nov. 25, 1964 (the same letter which was read at the Board meeting) the State Sanitary Water Board asked that a pond be excavated to handle the possible overflow which might bypass the sewerage treatment plant. The letter also shows that the State was aware, at that time, that plant expansion would be started and stated that when progress on this expansion could be shown, they (the State) would recind the 1000 limit on occupancy permits. At the present time the suggested pond has been excavated, construction on the expansion of the sewerage treatment plant has progressed.

When queried on this matter Mr. Albert Kaufmann, President of Surety Builders could not understand why building permits would be held up as, "it is occupancy permits the State refers to," said Kaufmann. A check made the morning of January 8 shows 878 water connections (which represent occupancy) made in the entire Village of Woodridge,

Police Chief Joel Kagann, in his summary and analysis of the activities of the Police Department, considered the year 1963 to 1964. Although juvenile complaints increased 78%, there was a 33% decrease in juvenile arrests.

18 obscene phone calls were reported last year whereas none were reported in 1963. Major crimes showed the largest increase percentage wise -- burglary 700%, larceny 400% and battery 900%. Tickets for speeding and stop sign violations decreased, while driving while intoxicated was on the rise.

Police manpower, including full and part time officers, now stands at 12, in addition to the crossing guard stationed at 75th Street during school hours. Officers handled 1,000 station complaints, 51 auto accidents, recovered two stolen cars and made 93 arrests during 1964, in addition to issuing traffic tickets.

Construction of a private swim and cabana club for residents of Winston Hills, new Winston - Muss Corporation community in suburban Woodridge, will begin in February, it was announced by Joshua A. Muss, vice president in Chicago for the building firm,

Completion is scheduled for Memorial Day, he said.

A contract for construction of the swim club has been awarded to Morris Handler Co., Inc., Chicago.


The \$200,000 project will include an "L"-shaped, Olympic-size swimming pool with twin diving boards; a separate, circular wading pool for youngsters; and a 120 by 40 foot clubhouse, including dressing rooms, a meeting hall for com-

munity gatherings, and a restaurant.

The pool will be 82 feet long by 40 feet wide at the base of the "L", Muss said, and 75 feet long by 35 feet wide vertically. The children's pool is 20 feet in diameter.

The swim club, which also will provide lounging areas for non-swimmers, will be located just off Hobson Road at Wood-ridge Drive, a quarter-mile east of Illinois Rte. 53, in what will be the center of the 1,850-home community.

Winston-Muss now is showing five model homes in Woodridge, ranging in price from \$18,900 to \$24,850. The models are on Rte. 53, three miles south of Lisle.





### From the Editor's Desk

Woodridge is a nice place to live, and filled with many wonderful people. You know this, your neighbor knows this, I know this . . . . but it isn't this that you read in the local papers.

And why not?

Is this village so different from others? Is it a special place where all the people that want to fight congregate?

If it isn't, why don't we read more headlines about La-Grange, Lemont, Lisle . . . . Why Woodridge?

I'm sure that in each town, each community, each block . . . . let's get down closer, each family, you find the same thing . . . . a difference of opinion. If we didn't have these variations - opinions, likes, dislikes, talents, vocations -- where would we find real progress? Where would a new idea be generated? and wouldn't it be dull.

There is a difference between these towns and Woodridge. They stick together and try to understand one another in the same manner that you try within your family circle to understand the differences in personalities and even in their mode of expression. You do not take all your differences and family troubles to everyone to talk about.

We need some of that family

During this past week we had an example of this situation. It arose over a leak in a basement foundation. This leak has existed for some time, it appeared before the warranty period was over, and though many attempts have been made to cor-

rect it (4) it still remains. Many of us have similar leaks in the basement which we have tried unsuccessfully to correct so we can readily understand this problem.

In checking the Better Business Bureau it was ascertained that a builders responsibility does not go beyond the warranty period. That basement leaks are very difficult to correct and that some responsible builders will return after the warrant period and try to amend them. To adhere to the established standards of the Better Business Bureau this is not necessary, though appreciated. We are speaking now of a leak that appeared under the warranty period, was corrected, and reappeared after the warranty expired.

Village Trustee, Robert Renaud has a leak of this type in the basement foundation of his home. Surety Builders has made many attempts to correct it before and after the warranty period.

In response to a recent request for repairs Mr. Kaufman sent a letter to Mr. Renaud stating "because of your obvious hostility to this company, as evidenced by your political activity, and because your warranty has long since expired, upon my specific orders this company will do no further work of any nature for you."

Mr. Renaud sent out copies of Mr. Kaufmans letter and an accompanying letter explaining his problem stating that at no time before or since he has joined the Village Board has he felt hostile toward the builders. His letter outlined the problem

and made a request that Mr. Kaufmans letter be published.

In the meantime, however, we shall conduct this administration with their interests and aspirations also in mind. We are all in the same family.

#### "Your Chief Says"

"Too many drivers using streets in Woodridge and the surrounding areas are driving with parking lights in violation of Illinois law," said Chief Joel A. Kagann, who warned that violating drivers and bicyclists who fail to obey Illinois will be cited.

The new law provides that drivers must use their headlights not only during the period from sunset to sunrise, but also during any other time when visibility is so limited as to require the use of lights for safety.

The State also requires that every bicycle ridden on a street or highway during the period of sunset to sunrise must be equipped with a lighted headlight and taillight.

Bike headlights must be visible for at least 500 ft, and must be white, yellow or amber. The taillight must be red and must also be visible for 500 ft.

"Many drivers apparently still do not realize that the Illinois traffic laws prohibit the display of parking lights on a vehicle while it is being driven unless the driving lights are also turned on," Kagann stated, meaning that drivers may not use parking lights only during the twilight or early morning hours.

"Drivers have been given warnings for violations of this nature as well as bike riders," Kagann said, although tickets will be issued to violators in the future.
