BACKGROUND DATA

The Unity Party asked our reporter, Shirley Manges, to be a candidate on their slate for the office of Village Clerk. As a result of this request Mrs. Manges telephoned the office of the Woodridge News seeking additional information on the Unity Party. In response to her request the following information was obtained.

All of the papers and documents referred to in this article are a matter of public record and are reprinted here in an endeavor to fulfill our obligation of informing the public.

1. GEN. NO. 61-719 February 5, 1962. The People of the State of Illinois VS Kenneth J. Brundage (Impleaded) Indictment for Conspiracy, etc., "We, the Jury, find the defendant, Kenneth J. Brundage, not guilty."

2. GEN. NO. 61-721 March 4, 1963. The People of the State of Illinois VS Kenneth J. Brundage (Impleaded) Indictment for Conspiracy, etc., Dismissed out of this Court.

3. GEN. NO. 61-722 May 6, 1963. The People of the State of Illinois VS Kenneth J. Brundage (Impleaded) Indictment for Conspiracy, etc., Dismissed out of this Court.

4. GEN. NO. 61-724 May 6, 1963. The People of the State of Illinois VS Kenneth J. Brundage (Impleaded) Indictment for Conspiracy, etc., Dismissed out of this Court.

5. INFORMATION NO. 63-07 May 6, 1963 arising out of Gen. No. 61-719 The People of the State of Illinois VS Kenneth J. Brundage.

"THEREFORE, it is considered, ordered and adjudged by the Court that the defendant, KENNETH J. BRUNDAGE, is GUILTY of the said crime of Attempt Petty Larceny in manner and form as charged in the information in this cause, and the said PLEA OF GUILTY." "It is therefore ordered by the Court that the said Defendant, KENNETH J. BRUNDAGE, be and he hereby is FINED in the amount of TWO HUNDRED (\$200.00) Dollars and NO COSTS."

"Fine of \$200.00 is paid."

In case Gen. No. 61-719 Kenneth Brundage and a physician were tried before a jury on a charge of conspiracy to defraud the United States Fidelity and Guarantee Company, 170 W. Jackson St. of \$7,600 in faked personal injury and accident claims.

They were reportedly named with 18 other persons in true bills by the grand jury as members of a fake accident ring.

Reportedly the ring had collected in settlement of these fake claims, about \$20,000 and had \$100,000 pending in other fake claims.

Mr. Brundage and a physician received a trial by jury before Judge Alexander J. Napoli. The judge simultaneously gave another attorney, Leo Holt, a bench trial. Mr. Holt had shared an office with Brundage and was also tried for conspiracy.

An ex-convict who had served prison terms for forgery and manslaughter, told the jury he had been paid \$2,102 to stage a 'phony' accident. He testified that the money was paid to him

your particular tests will be made by a doctor in charge. If a referral to your family doctor is necessary, you will be so advised.

The vision screening will include a check of all age groups for acuity and muscle balance; ages 7 - 18 will include a check for hyperopia, stereopsis and color perception while participants of 35 and older will also be checked for field and near acuity.

As stated, this service is made available to area residents through the Woodridge Woman's Club with the Downers Grove Lions Club at no charge because it is said that "anything less than vision at its best is a form of blindness".

Mrs. Ronald Ruble, Chairman of the W.W.C. Projects Committee asks that you bring any old discarded eye-glasses along when you come to the screening program. Open Letter To The People Of Woodridge

It has come to my attention that there has been some rumor of certain criminal indictments that had been filed against me. I feel that you can all understand my not volunteering this information before this, but since the rumors are quite prevalent, I feel it my duty to you as residents and prospective voters in the coming election to present as best I can a clear, factual history of this matter.

In 1959 I was employed as a claims supervisor at the United States Fidelity and Guaranty Company, just having passed the bar earlier that year. I was aware of and knew the company policy against attorneys or claim men practicing law part time, but being unable to leave the company because of lack of finances, I acted against the company policy and opened an office sharing expenses with several other lawyers with whom I had graduated. We all needed full time employment and tried to assist each other in obtaining clients and fees in order that we might some day devote all of our time and efforts solely to the practice of law. In November of 1959 as claims supervisor for this company, I settled a personal injury claim brought by five individuals who were represented by one of the lawyers in our office and against a person whose insurance was written by my insurance company. I had, of course, settled several other claims with other individuals in a like situation innocently with no dishonesty or violation of any principle, as the value of each case was set as a matter of company policy and an investigation had been made in each case by an outside claim adjuster.

In any event soon thereafter, it was determined by an organization known as the Association of Casualty Insurance Companies that these claimants or alleged injured parties were part of a phony accident ring. Upon their arrest and immediately prior to their trial, they were offered immunity from the State to give testimony against others allegedly involved. They then testified before the grand jury that not they but I, the doctor treating them and the attorneys representing them were in fact the ring leaders of the entire scheme.

I was tried in about February of 1962 and my innocence was confirmed by a verdict of not guilty by a jury as were the doctor and the other attorneys involved. The other four indictments arising out of other settlements remained in the hands of the State's Attorney and were continued from time to time for approximately one year. I think you can all understand the emotional, physical and financial strain that this matter caused me, especially since I was innocent, this strain became even greater. When the attorney whom I had hired had to withdraw because I could no longer afford to retain and pay him for additional trial work. A conference was held with the State's Attorney, myself and the then Presiding Judge, Irving Landesman, and, in view of the above circumstances of which they were all aware, the indictments were dismissed and despite my innocence an information charging me with attempted petty larceny and agreed stipulation of facts was

introduced, and a verdict of guilty was pronounced. This I felt concluded the matter.

Since certain groups of persons have seen fit to rehash and dig up my past experiences and skeletons. I feel, as I stated before, obligated to protest my innocence to you and to present as best I can the situation as it actually existed. This is not meant as a defense as I feel there is nothing truly to defend.

Since that time, I have never been reprimanded by any bar association and as a matter of fact the Bar Association has seen fit to appoint me to one of their committees and the Supreme Court has since assigned me cases for appeal representing prisoners incapable of affording counsel. My fellow attorneys have seen fit to accord me with certain honors and two insurance companies have seen fit to retain me to represent them in similar matters without reservation.

I have been asked to withdraw as a candidate for mayor by certain people so that the above rumors and information would be quashed. I discussed this with my fellow candidates and asked for their opinion. They have unanimously agreed that because of the fact that despite the record, I did nothing wrong, because the Bar Association has accepted me and appointed me to committee work and because a man should also be judged on his ideas, ability, qualifications and sincerity, that they would stand with me if I saw fit to continue to seek this office. I have decided to do so.

I ask that each of you search your conscience as I have done to decide if my candidacy would prejudice you in voting for the ideals of the Unity Party, the group which is best qualified to rebuild the effective government of this village by mature and intelligent representation.

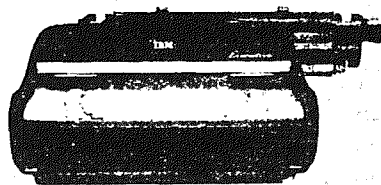

by Kenneth Brundage. Brundage was a claim adjuster for the insurance company at the time he was paid to stage the fake accident.

One witness testified being paid \$600 to ram into another vehicle while driving a demonstration car from an automobile dealer on Nov. 21, 1959. The reported accident was at 5400 S. Racine Street.

The first witness to associate Holt with the scheme testified Holt had him sign a paper after the accident claiming he had received injuries and asking the insurance company for money.

The physician who was on trial with Brundage admitted under cross examination to receiving a check for "something over \$700" from Kenneth Brundage. He stated that it was standard practice to submit medical bills to the attorneys of persons involved in personal injury claims.

The Assistant Vice President of the American National Bank testified that checks from the insurance company which were

made out to alleged accident victims, were deposited after endorsement by two attorneys, Leo Holt and Kenneth Brundage.

Brundage was described by his attorney in closing remarks to the jury as, "a gullible, unsuspecting schnook and a big jerk who was sucked in by the five who admitted staging the accident."

The jury after the eight day trial, deliberated two hours and ten minutes before reaching their verdict of not guilty. After the trial Assistant State's Attorney Albert L. Dunne indicated plans were under way to prosecute eight similar charges against the doctor and four against Brundage.

Leo Holt, who simultaneously received a bench trial by Judge Napoli, was sentenced to one to two years in the penitentiary.

In passing sentence on Leo Holt, Judge Napoli said, "I don't think that the jury verdict was very good. The State had a good case against Dr. Howard and Mr. Brundage. In fact, the evidence against Howard and Brundage was stronger than against this defendant."

The Information No. 63-07 on

which Kenneth Brundage was convicted by a plea of guilty for petty larceny arose from this case.

Leo Holt filed an appeal and on March 11, 1963 before Judge Dahl the case was nolle prosequi.

"Your Chief Says"

"Once you start, you have to stop" warns Chief Joel A. Kargann, who offers this advice to motorists who will need to stop their cars on slippery pavement many more times this winter.

Steering control will be better maintained with more effective stopping action if the brake pedal is rapidly pumped. This will prove far more effective than any effort to lock the wheels. To pump the brakes: apply the brakes quickly (lock them) for an instant, and, as quickly, release them for an instant. Repeat this -- on and off, on and off, once or twice a second to a full stop. The effect is to give short intervals for four-wheel braking, then of effective steering, when the brakes are released and the wheels roll.

Pumping the brakes is a good year 'round technique to use on any road surface you suspect might be slippery or treacherous. One short application will tell the story.

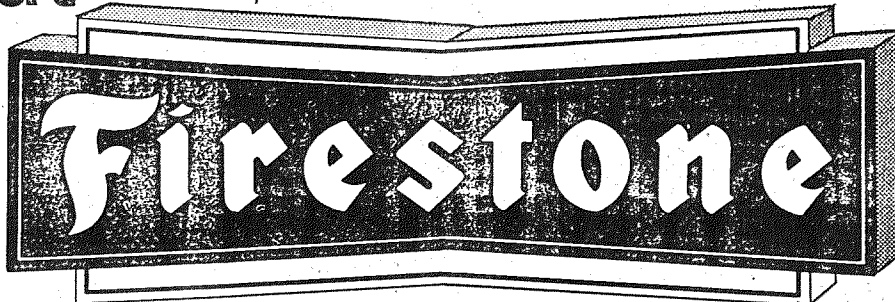

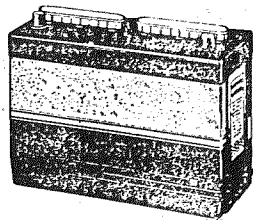
