PUBLIC HEARING DISPOSAL SERVICES

Saturday, February 27, 1965 a Public Hearing will be held at the Woodridge School from 9AM. to Noon The subject of this hearing is - disposal services.

With the renewal of Mr. John Rot's contract to service the Village of Woodridge there will be an increase of 50 cents per quarter. Presently the quarterly bills are \$4.50, so the increase, which is necessary to defray rising costs over the past five years, will bring the quarterly bill to \$5.00.

The question to be determined at the hearing is: Should the rate be increased an additional \$1.00 per quarter (bringing the quarterly bill to \$6.00) with additional services rendered by Rot. Those additional services would include lifting the present limit of 2 twenty-gallon garbage cans per household. Residents could then put out as many cans as they wish. Twice a year, said times to be announced,

heavy or bulky items would be. collected by the disposal service. Items such as, water heaters or chairs and the like. A possible amendment to Ordinance 64-4 may also be involved. This amendment could prohibit all burning of papers and the like within the Village

According to President Ed Redmond, the Winston Hills Homeowners Association is in favor of prohibiting all burning within the Village and increasing services and subsequently costs, of the Disposal Service. Other residents, said Redmond. have not voiced their opinions on these matters. The ultimate decision, which will be made by the Village Board, would affect the entire village of Woodridge, thereby all citizens. The only way to make your desires known to the Board, is to attend, listen to the arguments ask questions of either members of the Board or Mr. Rotatthe Public Hearing on Saturday, February 27.

An election will be held on Saturday, April 10, to fill two positions on the school board of District #68. These positions are currently held by Mrs. Olga Redfield, board secretary, and Mr. Lewis Benckendorf. They are currently completing a three year term.

A candidate for the school board must be a qualified voter and a resident of the state and of the territory of the district for at least one year immediately preceding his election. He must have a nominating petition signed by at least 50 eligible voters or 10% of the voters residing within the district.

Petitions may be obtained from Mrs. Nejdl at Goodrich School and are to be filed with Mrs. Olga Redfield, board secretary. The first day for filing nominating petitions is February 24 and the last day, March 20.

BLOOD MOBILE TO RETURN TO WOODRIDGE

The Mt. Sinai Hospital Blood Mobile sponsored by the Woodridge Woman's Club is returning to the village for the 2nd consecutive year, on May 26th.

If you are interested in participating in this program, you must keep in mind that anyone donating blood after Feb. 17th to any other group or individual will be ineligible, due to the 12 week period required between donations.

Three plans are available to those area residents who donate one pint of blood at the center. The pint entitles the donor or persons specified with coverage for all the blood and blood plasma needed, at the hospital of their choice anywhere in the United States, Hawaii, Puerto Rico and Alaska.

The programs available are: Family Transfusion Plan I which covers the donor and all members of his or her household for a period of one year. Family Transfusion Plan II covers the needs of all members of any household specified by the donor, for a period of one year and Family Transfusion Plan III covers the needs of an individual (the donor or another specified individual) for a period of four years.

Police Attend Control of Civil Disturbance Course

Chief Joel A. Kagann and Sgt. Jerome Sczcpaniak of the Woodridge Police Department graduated from a 40 hour course on Control of Civil Disturbance held at the DuPage County Fair Grounds during the week of Feb. 11th through 15th and Feb. 25th through 29th.

The course, held under the direction of Supt. Morris of Springfield, Illinois, was conducted to enable full time officers who attended to return to their departments to instruct part - time men in procedures which will be used in case of emergency. In the event of a disturbance, police throughout the State will have had the same type of training and will be in a position to integrate with other departments, all using the same signals and procedures.

Subjects covered during the course included investigational procedure, discussions on mob behavior, riot control formations, human relations, riot baton and use of gas. During the discussion of the latter, officers were actually given gas so that they would recognize its smell and taste and be aware of reaction to its use.


Illness has hit Woodridge again and with this ever changing weather its no wonder. We hope by the time this is printed that everyone will be up and around again.



1962-63

The officers elected for the 1962-63 year was: Mrs. Genevieve Gray, President; Mrs. Dorothy Provo, Vice - President; Mrs. Loretta Runnfeldt, Recording Secretary; Mrs. Dorie Keller, Corresponding Secretary; and Mrs. Helga Scudder, Treasurer.

Special projects to raise money to purchase items for the school were: a bake sale, the saving of pepsi plus caps, monthly movies for the children, and the biggest money raiser for the year was a fashion show entitled "Paris in the Spring," which was held on Feb. 13, 1963.

Mrs. Loretta Runnfeldt resigned as recording secretary and the board nominated Mrs. Lorainne Larson to fill this vacancy.

On Jan. 9, 1963 Mrs. Loretta Larson sent a letter of resignation to the president, Mrs. Genevieve Gray,

At the Jan. 15, 1963 meeting, Mrs. Genevieve Gray announced that she would have to resign her post as president as her husband was being transferred to South Bend, Indiana.

The following were unaminously elected by the board to fill the unexpired term; Mrs. Dorothy Provo, President; Mrs. Ruth Vondrasek, Vice - President and Mrs. Dorie Keller Recording Secretary.

Items purchased for the school by the Mothers Club were: a cover for the chair in the teachers room, a piano and bench cover, vinyl draperies for 10 classrooms, wall cabinet for the kitchen, a plastic tablecloth to be used by the Mothers Club and a 100 cup percolator which was purchased by selling 36 bottles of pure vanilla and 24 cans of black pepper at \$1,00 each, 1963-64

The newly elected officers were: Mrs. Dorothy Provo, President; Mrs. Ruth Vondrasek, Vice - President; Mrs. Dorie Keller, Recording Secretary; Mrs. Nan Davis, Corresponding Secretary and Mrs. Geane Modersohn, Treasurer.

On October 19, 1963 the Mothers Club held their first annual "Fun Fair", which included rides, games and refreshments which proved to be very successful. A total of \$728,67 was profited.

Items purchased for the school by the Mothers Club draperies for the school office, draperies for 10 additional rooms, library books, shades for the skylites in the gym, educational records, subscriptions to science magazines and a paper cutter to be used by the Mothers Club.

Money raising projects for this year were; monthly movies for the children, the Fun Fair, a bake sale, saving of pepsi plus caps, and the sale of sweatshirts, head scarves pennants, t-shirts all bearing the Wildcat emblem with the school colors of brown and gold.

Remember, the Mothers Club is open to all Woodridge Mothers, whether or not they have children in school, The cooperation of EVERY mother is needed if we are to succeed in our plans to help our school,


POLICE HANDLE AUTO ACCIDENTS
